President Taylor called the meeting to order at 6:00 pm

Approval of minutes Quarterly minutes July 20th - V. President Stallworth moved to approve the July 20th meeting minutes as written, seconded by President Taylor, the majority voted yes and one no vote by John Dantzler; the motion carried

Approval of Special Meeting held August 26th - President Taylor moved to approve the August 26th meeting minutes as written, seconded by V. President Stallworth the majority voted yes and one no vote by John Dantzler; the motion carried,

Community Group Manager reported on the 3rd Quarter Income Statement and Delinquencies Equity Experts Collections.

3rd Quarter Financials as of September 30, 2017 the community has an operating balance \$32,530.89. The manager stated "we are still collecting on the homeowners past due accounts we collected an additional \$627.91 from June-September."

Manager recommended to the board the reallocation of the retained earnings deficit of \$499.43 to the Contingency Reserve. The deficit is due to a previous homeowner balance with HCS. Completing this reallocation will leave a balance of \$15,788.06 in the Contingency Reserve."

President Taylor asked if the Budget and Finance Committee had an opportunity to review this and if they are in agreement with this recommendation. The chairman of the Budget and Finance had no issue with this recommendation. President Taylor moved to approve to reallocate the deficit to the contingency reserve fund properly seconded by V. President Stallworth motion carried.

The Income Statement was given by the manager she explained "since the HOA collects assessment at the beginning of the year we usually won't have any assessment capital coming in during this time; however there was a home sold and from that sale we received \$150.00 this quarter which was applied to working capital."

She stated we are under budget for this quarter ending September 30th, except for landscaping cost because of the purchase and installation of lights. The only other item over was management fees because historically the previous manger under charged the HOA for his time

which is the reason for the difference. The 2018 budget has taken this into account. She also stated "all reserves were funded during this quarter".
